- **Sales Tax Collections – Impact of Marketplace Facilitator Language**

- Federal Response: In a 5-4 decision, the U.S. Supreme Court overruled Quill and Bellas Hess. South Dakota v. Wayfair, 138 S.Ct. 2080 (2018)
 - Out-of-state sellers, even if the seller does not have a physical presence in the taxing state must remit tax
- State Response: Colorado HB 19-1240
 - Required marketplace facilitators to collect on behalf of marketplace sellers on their marketplace
- Municipal Response: Greeley
 - Uniform definition for Sales, Use, and Lodging Code:
 - Marketplace Facilitator (3rd party Sellers, who bring Vendors & Buyers together)
 - Marketplace Seller (Seller who owns their product)
 - Multi-Channel Seller (Seller who may market through multiple avenues)
