2022 Budget

- Review of Greeley's economic health indicators throughout the first quarter of 2021.
- Review of projected new housing permits through 2026.
- Review of 2022 forecasts & the budget development considerations.
 - The City is forecasting a \$9.8 million growth in ongoing revenues in 2022.
 - \$5.9 million growth in Sales & Use Tax.
 - \$1.4 million growth in Property Tax.
 - \$2.5 million growth from other revenue streams.
- Review of 2022 forecasted tax revenue (\$118,294,180)
- Review of 2022 forecasted Operating & Capital revenue excluding transfers.
 - 2022 Operating Revenue: \$231,989,716.
 - 2022 Capital Revenue: \$85,464,642.
- Review of the approved increases to the 2022 Budget (\$18,601,466).
 - Ongoing funded requests: \$7,614,826.
 - One-Time funded requested: \$6,062,445.
 - Investment in City staff: \$4,924,195
- Review of 2022 General Fund Operating expenditures excluding transfers (\$115,431,208).

- Review of 2022 Enterprise Fund Operating expenditures excluding transfers (\$47,669,292).
- Review of utility rate changes & the forecasted average monthly single-family residential utility bills.
 - Stormwater bill: \$1.54 increase.
 - Sewer bill: \$4.22 increase.
 - Water bill: \$4.16 increase.
 - Total: \$9.92 (9.8%) increase.

Charter Amendment Initiatives

- Discussion about how Greeley's water supply challenges are linked to several factors (growing regional population, finite water supply, & a major agricultural economy).
- Overview of how the City currently makes timely water decisions to ensure reliable water delivery.
- Review of the proposed charter amendments that were initiated by "Save Greeley's Water" and how they would add two new sections to the City's Home Rule Charter.
 - Section 17-9 would require additional engineering and elections on many water-related matters (long-term leases, trades, and the sale of water & water facilities).
 - Section 17-10 would require additional engineering and elections before the city could purchase, lease or use groundwater or recycled wastewater for drinking water or irrigation (non-potable) use.
- Discussion about how the sections would negatively impact the City.
 - Annual special elections would cost roughly \$1 million per year.
 - Water acquisition costs will increase.
 - Could significantly impact timeliness and approval since a majority of all registered voters (without considering voter turnout) must vote.

2022 Budget Recommendation

- CBAC unanimously votes in favor of recommending the 2022 Budget as presented.

Review of Upcoming Agenda Items

- October's agenda items will be confirmed by Monday, October 11th.

Requests & Open Discussion

- CBAC would like to discuss the American Rescue Plan Act (ARPA) and the ALLO broadband project in the coming months.
