6. **New Business and Action Items:**
 - a. Geometry of Flight Deaccession – Staff and the RAMP committee recommend approving the second and final vote to deaccession the ‘Geometry in Flight’ sculpture by AJ Davis that is located Near 1130 8th Ave. The metal sculpture was installed in 2016. The entire foundation will need to move to the South ten feet when new construction commences at that location and the curb and the sidewalk are redesigned; this could take several years to complete. The falcons have been down for over a year waiting for repair and the metal tubing that is wrapped around the pole has rust showing. City staff is working with the artist to consider if the falcons can be placed elsewhere in the City and agree that the sculpture as a whole no longer exist. Staff has concluded the artwork is damaged to an extent where repair is unreasonable or impractical. ACTION: Vote to complete the deaccession process.

7. Project Reports:

- a. Arts Picnic Booth – No Changes
- b. Traffic Cabinet Vinyl Wraps – Five approved artists are actively submitting designs to Raven Signs for printing, including one student from Franklin Middle School. The sixth artist that we had approved whose design was designated for the cabinet on 18th St and 1st Ave did not respond to the contractual offer. Because we are looking for an artist with ties to the community that the cabinet is located and no other artists in this round fit, we will put this cabinet in the next round of wraps to be juried.
- c. Glenmere Park Art – The project is moving forward. The compass rose with decorative concrete has been installed; two kinetic sculptures will be installed on October 1, 2021.
- d. Art Commission Q2 Inspections – All Q2 inspections should be in; if not please make sure they are submitted in the next week. Q3 inspections will begin in July. Please let Kim know if you have questions or concerns.
- e. InStall Art –Raven Signs is scheduled to install the week of June 21.
- f. Winds of Change II – The sculpture has been poured at the artists' studio in Pueblo CO. Art is scheduled to be installed on July 14, 2021.
- g. East Greeley Park Art/Chair Danyelle – No changes. Art installations for Balsam Park and the Natural Area are projected for September/October 2021. Wes is happy with the park design and sees lots of opportunities to incorporate his artwork. Wes has been given the 'go ahead' by the committee to create his art 'in the field' as he goes. His ideas will be fluid, yet they will stay true to the concepts we have approved
- h. Fire Station #6 – No changes. The model has begun the casting stage. Installation will be pushed out beyond July; no date has been given yet.
- i. IG Trailhead Marker Art – No changes - conversations have begun with artist Marjorie Leggitt for botanical drawings that might be placed at the new Island Grove Poudre trailhead.
- j. Excel Energy Utility Cabinets – No changes - we had request from Xcel asking for box locations for their tech's to check for live/dead fronts; we are hopeful that we can wrap additional boxes this Fall or in the Spring 2022.

8. Maintenance & Repair

- a. 'Blue Gramma' located on Reservoir Road near 21st Ave had a tack weld come loose last month during a storm. The weld has been repaired and an additional ring was added for extra strength.
- b. Skateparks/Peakview and 23rd Ave – Sculptures at both Parks have had graffiti that needed to be removed. The process is to sand down the metal and add chemicals to encourage new rust to form. We will know next week if we need to apply more chemicals, otherwise the maintenance is complete.
- c. Base for 'When Champions Meet' at Island Grove –One of the large 24inx24in tiles had fallen off the base. The concrete contractor that was working at Glenmere Park reinstalled the tile for us; he will also add grout all around to prevent more tile from falling.
- d. 'The History of Greeley Transportation' - Repairs to be made to at the Transit Center have been rescheduled for September 2021. Artist Kirk Seese did bring a new 'Feather' sculpture for us consider purchasing; it is at the NE corner of 9th Ave and 8th Street.

10. Maintenance & Repair

- a. Aspens and Moon by Reven Marie Swanson – the four piece series located on the corner of 10th St and 71st Ave at Boomerang Golf Course needed repair. Kim noticed while driving by that the moon was hanging low. A weld had broken from natural aging and wear. Reven drove up from Denver and welded the moon back into place on site within two days of the report and repainted the moon. It looks great once again. Reven is a dedicated artist!
- b. Pioneer Couple tree carving at Plumb Farm update – the Plumb Farm will remain City of Greeley property. The Art Commission deaccessioned the artwork in 2020 due to extensive natural cracking and deterioration. The museum staff will leave it in place until it becomes a danger to the public or it is not longer presentable to the public at which time the public art program will have it removed.
- c. Butterfly Ball – completed, a new clear coat has been applied
- d. 'The History of Greeley Transportation' - Repairs to be made to at the Transit Center have been rescheduled for June 2021. Artist Kirk Seese did bring a new 'Feather' sculpture for us consider purchasing; it is at the NE corner of 9th Ave and 8th Street.
