1. The meeting was called to order by Mark Pugatch at 3:45pm

2. Approval of June Minutes
Motion to Approve the August 2023 minutes made by Perry Bell and seconded by Alison Hamling. Motion passed unanimously.
3. New Business Minute
 - We welcomed Daniel Knopf to the board and made introductions.
 - A donation request for the Windsor High School Music Boosters came in after the agenda had been sent. Perry moved to add the request to the agenda and Alison seconded. The board approved to award them a voucher for two tickets to On Your Feet.
 - Monica Smith and Kirsten Simmons from Midwood Entertainment gave a presentation to give the board a baseline understanding of how the talent buying industry works, Midwood's position in the industry and how they are programming for the UCCC.
 - The agenda item regarding Advisory Board At Large Members was discussed. After much discussion, it was decided that the invitation and participation of At Large Members did not require formal action with the understanding that all meetings of the Advisory Board are open to the public and anyone can attend without being invited or solicited.
 - Stephen Marquez has been hired as the UCCC Manager and will begin his employment on September 21st.
4. Old/Ongoing Business
Fall 2023/Spring 2024 Programming updates.
 - Martina McBride expenses came in lower than anticipated and the show met the cost recovery. Josh Turner is on track to meet full cost recovery and Robert Cray is at 83% cost recovery at this point. Ad campaigns are just starting for the additional fall shows.

 - The Backstage Stars are giving presentations to groups and are trying to obtain corporate sponsors.
 - There has been a change to how the Backstage Stars are doing their beverage sales, due to liquor licensing requirements.
