GOLF ADVISORY BOARD
MEETING MINUTES – May 9, 2024

1. ROLL CALL

The Golf Advisory Board met on Thursday, May 9, 2024, at 4:34 p.m. Board members present: Pat Gilliam, Philip Taylor, Patti Brug, Adam Klett, and Kim Spencer. Staff present: Chris Colling (Golf Manager), and Greta Steinmetz (CPRD Office Manager). No public was present.

2. APPROVAL OF MINUTES

No changes were noted for the March 14th meeting minutes. Patti Burg made a motion to approve the minutes, seconded by Kim Spencer, and the motion carried 5-0.

3. PUBLIC INPUT

There was no public input.

4. OLD BUSINESS

Pat Gillum discussed the attendance by-laws for Chris Lomas' absences. Mr. Gillum reached out to Mr. Lomas with no response. A recommendation to fill seat was made at the March 14th meeting. Patti Burg made a motion to fill the vacancy, it was seconded by Adam Klett, the motion passed 5-0.

5. NEW BUSINESS

Future Planning for Greeley Golf Courses - Phill Taylor presented his thoughts on the future planning of Greeley Golf. The ideas included facilities the City could alter and sell to fund revamping Highland Hills Golf Course and a new 27-hole course. Mr. Gillum suggested that the board develop two or three ideas and present them to the city planners. There is a need to expand the golf opportunities for the communities. Mr. Colling will share the suggestions with Diana Frick, Culture, Parks, and Recreation Director, and see where they go from there. He will bring in someone from the Planning Department to share plans for the City. Adam Klett shared the Berry Dunn website so the board members could take the survey.

Restaurant Review—Kim Spencer shared that some people sent her links about Bogies not having a health inspection yet this year. Most of the issues were resolved except for the flies. Other problems include smoking too close to the door, over-serving alcohol, and rowdy crowds. Patti Burg added Bogies has old tables stacked around the building, feeding the squirrels, issues in the ladies' room, and broken tables stacked around the building and in the hall. Chris Colling will speak to both facilities. Due to his experience with food, he completes monthly inspections. He mentioned that both restaurants received a one-year extension on their contracts in April and May.

6. STAFF REPORTS

Boomerang has had 7,471 rounds so far this year. The new deck is in bid status. The short course is in the planning phase, and we are going through the proper departments for approval in preparation to go to bid in the fall. The greens, tees, and fairways have been aerified. Maintenance will install mats on the driving range.

Highland Hills is making significant changes, including the replacement of the sidewalk on the east side of the clubhouse, the dirt area in the courtyard, and the asphalt cart path. The greens, tees, and fairways have been aerified, and the rough has been cut half an inch shorter. Notably, the Russian Olives on the 15th hole have been removed and will be replaced, enhancing the course's visual appeal. The CGA will be re-rating Highland Hills in July.

Philip Taylor resigned from the board due to moving out of Greeley. The Board thanked Mr. Philip for his service.
