Union Colony Civic Center Advisory Board

November 12, 2025, at 3:45 p.m.

1. The meeting was called to order by Mark Pugatch at 3:45 p.m.

2. Approval of September 2025, minutes.

Motion to approve the September 2025 minutes made by Daniel Knopf and seconded by Robert Wasson.

Motion passed unanimously.

3. Introduction of new board member.

- The board members went around the room and introduced themselves, as well as the staff.

4. Election of Vice Chair:

Motion for Daniel Knopf to be elected as vice chair made by Mark Pugatch and seconded by Robert Wasson.

Motion passed unanimously.

5. Old/Ongoing Business:

- Renaming Survey Results:

- The survey showed that 77% of people do not want to change the name of the UCCC. The city staff recommended to not proceed with this item. The board decided to inform council of the findings.

Motion to accept survey results for what they said and note that 669 responses, of which, the majority wanted to keep UCCCC name with reasons for a historical connection and a majority of respondents were patrons and Greeley residents made by Daniel Knopf and seconded by Cathy Salaymeh.

Motion passed unanimously

Motion to move the current city "Union Colony Civic Center" sign to support survey results in retention of the name made by Robert Wasson and seconded by Jodi Witter.

Motion passed unanimously.

Motion to request to investigate improved marketing and promotion programs, to respect the sentiments of the survey and ongoing discussion within the board which has emphasized a greater need for inclusion of all segments of the city and to attract all demographics made by Mark Pugatch and seconded by Daniel Knopf.

Motion passed unanimously.

- Fall Season Update: Stephen gave an update on the fall shows cost recovery and then gave a quick update for upcoming spring shows.

6. UCCC Backstage Stars Report:

- No report was given for the backstage stars.

7. Ticket Donation Sub-Committee Report:

Motion to add Ticket Donation Subcommittee recommendations for action to main agenda. Unanimous agreement

Motion to approve sub-committees request to give 2 tickets to Hades Town and reschedule the 4 tickets that were originally from Celtic Thunder made by Mark Pugatch and seconded by Daniel Knopf.
