Union Colony Civic Center Board

February 11, 2026

1. The meeting was called to order by Mark Pugatch at 3:45 p.m.

2. Approval of the January 2026 minutes

Motion to approve the January 2026 minutes made by Perry Bell and seconded by Dan Knopf.

3. New Business:

- Ticket Donation Subcommittee Report: The sub-committee recommends that the board approve 2 Vouchers given to Life Stories, and 2 Tickets to TUSK given to Self-sufficiency.

4. Old Business:

- Fall/ Spring Season update:
 - Stephen gave an update to the board about ticket sales, cost recovery, and upcoming shows. The board communicated their congratulations for the season as they do not recall a better year with cost recovery.
 - Dan Knopf speaking as a board member would like to show his support for the shows that are community minded.
 - Stephen announced that Midwood has split to Belle City Entertainment, and they are working well with Stephen and the team.
- Sign Relocation Discussion:
 - Mark Pugatch opened this discussion with a motion.

Motion as a result of the center renaming survey, the Union Colony Advisory Board in their November and January meetings have met and discussed several strategies going forward. One of these was to seek City consideration to relocate the existing lettering and its associated wiring currently on the front of the building to an area above the box office.

In furtherance of that objective, the Union Colony Civic Center Advisory Board respectfully requests city staff to:

- Evaluate whether this request could be considered within future capital planning efforts within the department's capital improvement projects.
- Once considered, work with this Board to assess funding considerations.
- It is our understanding that any subsequent steps including cost estimates or vendor engagement would only occur after a funding direction is established.

This motion was made by Mark Pugatch and seconded by Dan Knopf.

Motion passed unanimously.

5. Other:

- Backstage Stars Report:
 - Google ads from Zoggle marketing are on its way. Jason is just waiting for the Fall season schedule to be finalized.
 - The prototype for the cup holders was presented to backstage stars. More to come for this item.
- A discussion for the consolidated board commenced:
 - Megan Weiler gave an update on the council work session. Council gave the green light for staff to explore the idea of consolidating the 3 culture boards.
 - A survey was sent to board members requesting feedback and gauging interest in the new commission. Members were encouraged to fill it out.
 - There was discussion between the board that they felt the attendance slide did not convey their attendance clearly. There were questions as to if the consolidated board would really be beneficial without specialized interests.
 - There was also a discussion about the time needed for the board or the potential sub-committees.
 - Staff thanked the board members for their comments.
